This regular meeting of the shareholders is of dual purpose; i) serve as the Annual Meeting of InSite Platform Partners, Inc. InSite Platform Partners, Inc., d/b/a North American Satellite Corporation, is now the licensee of SkyTracker™ and thus the revenue producer of the two corporations. A notice to describe the acts perpetrated against NASCorp was emailed to NASCorp shareholders last year who had on file an email address. It also advised what actions had been taken to secure individual investment(s) through InSite and InSite's actions to recover damages for NASCorp. These Meetings will further detail those actions.

Minutes to the last NASCorp Annual Meeting of Shareholders will be read; events not fully known at that time that an environment had been set up by a well-orchestrated political machine that prevented any possibility of shareholder dividends.
